Buffalo Youth Shooting Sports began in 1978 as the Buffalo Jaycee Shooting Education Program. The organization has evolved into a volunteer, parent run organization which has a "Non Profit Corporation" status under Minnesota State Law and is recognized as a 501c3 organization with the IRS.

The threefold Purpose of BYSS as stated in the By-Laws (posted on-line at www.BuffaloBBGun.webs.com) is:

- *to encourage youth to become educated in the shooting sports by providing a Shooting Education Program, stressing the main ingredients of Safety, Education, Enjoyment & Competition to area youth ages 8 - 15.*
- *to instill the highest regard for firearm safety and sportsmanship in every participant involved in the Program.*
- *to help participants prepare for competitive gun safety exams and practice the fundamentals of shooting during regular training sessions on a 5 meter range shooting Daisy/Avanti BB guns in preparation for BB gun competitions sponsored by Buffalo Youth Shooting Sports as well as invitational BB gun competitions in other cities and states; including State and National Championships.*

BYSS Membership consists of area adults interested in fulfilling the above threefold purposes of the organization. Annual BYSS membership dues are \$30 which covers both parents of a family and free registration for one child to participate in the 2018 Shooting Education Program. The registration fees for additional children from the same family are \$30 each, with a maximum family registration fee of \$100.
